## Coach Canning

Michele Canning is entering her seventh season as Head Coach at New York University. In 2014, Canning was named Eastern College Athletic Conference (ECAC) Metro Coach of the Year, while she and her assistants were selected UAA Coaching Staff of the Year. Over her 7 seasons with NYU, Canning has recorded 3 ECAC Championship appearances, the first program at-large bid to NCAA tournament, and the first NCAA appearance in over a decade. During Canning's tenure, the all-time points record has been broken three times- 2013, 2014, and 2015. Canning also marked the program's first ever individual UAA award for Rookie of the Year in 2015. Canning came to NYU with 15 years of Division I coaching and playing experience at Seton Hall and St John's University. Canning is also currently the Head Coach of the NY Surf UWS women's team.
